According to the Report, emissions resulting from human activities are substantially increasing the atmospheric concentration of GHGs. This is true, in particular, for carbon dioxide emissions, which result mainly from the burning of fossil fuels. The IPCC estimates that, in the last thirty years, the increase in the atmospheric concentration of CO<sub>2</sub> has been substantially higher than in the last two centuries and the actual level is the highest among those registered in 160,000 years. The increasing atmospheric concentration of GHGs will enhance the greenhouse effect, resulting on average in an additional warming of the earth's surface. The main greenhouse gas, water vapour, will increase in response to global warming, and will further enhance it.
