For this purpose, Woolf's work "A Room to Herself" will be examined and her statements regarding androgyny and gender roles will be analyzed. Then, "Orlando" is presented as a stand-alone work and the concepts of the biographer, who is the narrator of the novel, and of time are emphasized, as they are fundamental to the overall understanding of the work. In the analysis, different thematic areas are analyzed for their representation of gender. These include the change of identity as well as the social circumstances in which Orlando lives, the search for truth, love, the recurring symbol of the oak tree, which is associated with poetry, and Orlando's appearance, which Woolf punctuated with inserted images of t
